Bird Blitz 2009: St. Mary's River

Bird Blitz surveys in 2009 targeted two large, forested blocks in the St. Mary's River watershed in central St. Mary's County to the north and south of Leonardtown. These forests are a mix of oak-hickory, oak-pine, and loblolly-shortleaf-pine associations. The lands in this area include a number of privately owned parcels, as well as tracts owned and managed by the Maryland Department of Natural Resources (DNR). These DNR lands encompass nearly 3,460 acres which make up St. Mary's River State Park on the east side of Indian Bridge Road and the Salem Tract, run by the Forest Service, on the west side. Volunteers utilized DNR trails, service roads, and other roads lending access to the area's forests to achieve coverage of the area this summer. All together, 7 volunteers conducted 8 Bird Blitz surveys, and traversed 47 km of transects during more than 22 survey hours (Table 1).

The results are summarized below in Table 2. It is important to note that Bird Blitz survey totals represent minimum population estimates of breeding pairs. Actual populations are higher because not all available habitat was covered and because some birds along a route may not be counted (if they were silent and/or hidden while observers passed by). There were 8 at-risk species recorded in 2009. Even though none of the counts for these species exceeded IBA thresholds, relatively high counts were recorded for Worm-eating Warbler, Prairie Warbler, and Wood Thrush (Table 2). These counts indicate that populations for these at-risk species could exceed thresholds for the area. Bird Blitz results also demonstrated that the area supports a relatively high diversity of Forest Interior-Dwelling Species (FIDS) with 18 FIDS recorded out of 24 possible in Maryland's Coastal Plain forests (Table 2).
