

# Raising our voices for the birds

But the rain did not deter Audubon's important work on behalf of birds. In Maryland, the state's annual legislative session ended with the passage of new environmental laws supported by Audubon and our passionate members. A new nesting raft was launched mid-month that has already attracted terns, including one that had been hatched on the raft two years ago. In Pennsylvania, our ongoing habitat restoration work in Cobbs Creek Park attracted bird and nature lovers alike on Earth Day. And Philadelphia staff have been mesmerized by a pair of bald eagles who are nesting near the Discovery Center.

May's strong sun is now shining and our region teems with energy and activity. This month, we will again host our amazing Baltimore Birding weekend. And if you cannot get to Baltimore, we invite you to join us on an upcoming bird walk at the Discovery Center or John James Audubon Center. Binoculars are available for those who may not own a pair—do not let a lack of expertise stop you from joining us. Everyone is welcome!

We also invite Pennsylvania residents to raise their voices on behalf of birds and

weigh in on a proposal by the Maryland Air National Guard to make flight training runs in the Pennsylvania Wilds. We will also send out Action Alerts to Pennsylvania's members as this year's Pennsylvania budget negotiations proceed.

There are many ways to show your support for birds and the places they need. Thank you for all of the ways that you help us advance our important work.

### Cove Mountain Phase II

In 2022, Audubon Mid-Atlantic teamed up with the Nature Conservancy to create a migratory stopover habitat at Cove Mountain, just outside of Harrisburg, to support birds travelling along the Kittatinny Ridge during spring and fall migration. This spring, partners have created additional stopover habitat at the site, planting 625 native tree seedlings, including Gray dogwood (Cornus racemosa), Black chokeberry (Aronia melanocarpa), Northern spicebush (Lindera benzoin), and American elderberry (Sambucus canadensis).

The Audubon Mid-Atlantic forest team is also beginning to conduct spring migration surveys, which are designed to determine the species of neotropical migrants that are utilizing the restoration area. 
### Legislative Accomplishments in Spring 2023

Maryland's annual legislation session ended on April 6 with a round of lastminute legislative wins that help advance Audubon's regional environmental agenda. Many thanks to the hundreds of Maryland Audubon supporters who weighed in with their legislators over the past three months. We could not have done it without you. Highlights include:

- The Forest Conservation Act, which will update forest conservation goals and definitions to reflect new data, protect and conserve more forest land, and give local governments flexibility to pursue solutions that advance equity.
- The Power Act, which sets the goal of Maryland producing 8.5 gigawatts of off-shore wind by 2031 and updating the state's transmission grid. This is a significant step forward in climate action as increasing renewable energy production will work to mitigate climate change induced habitat loss throughout the region.
- The Maryland Sustainable Buildings requires all buildings receiving 50% public funding in Maryland to meet the LEED standards that prevent bird collisions and conserve building energy usage. Read the press release here,
- Make Community Solar Permanent, which makes permanent a community solar pilot project, with the goal of incentivizing access to renewable energy by low- and moderate-income residents.
- And the Pollinator-Friendly Powerlines Bill, which prohibits the enforcement of "weed" height ordinances some powerline corridors and allows electric utilities to create pollinator friendly habitat in those corridors rather than continual mowing.

In Pennsylvania, we remain focused on efforts to create sustained, robust funding for both the Department of Environmental Protection, and the Department of Conservation and Natural Resources in order to invest in statewide habitat protection and natural climate solutions. We will also continue working in the state to make sure Pennsylvania stays a member of the Regional Greenhouse Gas Initiative (RGGI) in order to invest RGGI proceeds into renewable energy, habitat conservation, and green infrastructure throughout the state.

### Whitby Meadow Restoration Spring Update

This spring, volunteers from the Cobbs Creek Trail Ambassadors, Darby Creek Valley Association and Master Watershed Stewards joined Audubon Mid-Atlantic at the Whitby Meadows restoration site to plant 200 live stakes along the banks of Cobbs Creek, plant native fruit bearing shrubs along the edge of the meadow and remove litter and debris from in the creek. The trees planted last fall are holding up well and in time will help to increase canopy coverage along the creek, casting shade and providing habitat and food for native birds and other wildlife.

On Earth Day, many community members stopped by the Cobbs Creek Trail Festival hosted by the Clean Air Council and partners, which included a great bird walk through the meadows lead by the In Color Birding Club. Audubon, Land Health Institute and the Cobbs Creek Trail Ambassadors led a volunteer planting and cleanup working with the Omega Omega chapter of Alpha Kappa Alpha sorority, who rallied around 100 volunteers to help brighten up the newly improved trailhead leading to the meadows. Afterwards many of the volunteers joined staff for a guided tour through the meadows to appreciate the returning spring birds and the efforts of all of the restoration volunteers. This training would occur as low as 500 feet over affected state park and recreation areas.
