Bird Blitz 2009: Nanjemoy

The Nanjemoy candidate IBA in southwestern Charles County was another top priority for Bird Blitz surveys this year due to the rich biodiversity found in this large block of contiguous forest and the widespread development pressures in the county. The 2009 surveys included Maryland DNR and federal BLM tracts of the Nanjemoy Natural Resource Management Area, Purse State Park, Doncaster State Forest, The Nature Conservancy's Nanjemoy Preserve, and numerous adjacent forested areas. This extensive area received excellent survey coverage, as 11 volunteers conducted 20 surveys, including important nightjar data collected during the Charles County May Count. All totaled, 127.5 km were hiked and kayaked during more than 52 survey hours (Table 1).

The results are summarized below in Table 2, with highlighted species representing those which matched or exceeded their state-level IBA thresholds. It is important to note that Bird Blitz survey totals represent minimum population estimates of breeding pairs. Actual populations are higher because not all available habitat was covered and because some birds along a route may not be counted (if they were silent and/or hidden while observers passed by). There were 10 at-risk species recorded with Whip-poor-will and Worm-eating Warbler surpassing their respective IBA thresholds of 10 pairs and 20 pairs. Other at-risk species with high counts that were below IBA thresholds were Wood Thrush and Prairie Warbler (Table 2). These results also indicate that the area supports a high diversity of Forest Interior-Dwelling Species (FIDS) with 21 FIDS recorded out of 24 possible on Maryland's Coastal Plain (Table 2).
