

## **Important Bird Areas Program**

### **Bird Blitz 2009: Zekiah Swamp**

Zekiah Swamp is located in eastern Charles County and includes more than 25 km of braided streams stretching southwest from Cedarville State Forest to Allen's Fresh Run and the Zekiah Swamp Natural Environment Area. The majority of the land in this area is privately owned and remains intact and undeveloped. The area's name derives from the Algonquin word *Sacaya*, meaning a dense thicket, and accurately describes the shrub wetlands supported by Zekiah Run. Other significant habitats in the area include oak-hickory floodplain forests, adjacent upland forests, as well as snag-filled pockets of herbaceous wetlands – resulting from beaver activity. This summer, Audubon staff conducted 3 Bird Blitz surveys at Zekiah Swamp, likely covering less than 10% of the total area of these habitats. Approximately 27.3 km of transects were traversed during 19.25 survey hours (Table 1).

The results are summarized below in Table 2; highlighted species are those which matched or exceeded their state-level IBA thresholds. Bird Blitz survey totals represent minimum population estimates of breeding pairs – actual populations are higher because not all the habitat was covered and because not all birds along a route were counted (if they were silent and hidden while observers passed by). There were 7 at-risk species recorded, with Prothonotary Warbler surpassing its IBA threshold of 30 pairs. Other at-risk species with notable counts below their IBA thresholds were Red-headed Woodpecker, Kentucky Warbler, Louisiana Waterthrush, and Wood Thrush. The survey results also indicate that the area supports a good diversity of Forest Interior-Dwelling Species (FIDS) with 17 recorded out of 24 possible on Maryland's Coastal Plain. These data will greatly assist our review of this area as a potential IBA later this year.
